Park Reservations	\$10.00 per hour
Special Event Fee*	\$1.00 per person over 200 people
Ice Houses (Winter Only)	\$30.00 per day (includes 1 bundle of wood)
Firewood	\$5.00 per bundle

*This fee is in addition to the pavilion/park rental. This fee can be negotiated up to 70% off in exchange for services. Refer to non-governmental fee policy for qualification.

CHENA LAKE CAMPING

RESERVE A SITE:

- #1 OCCUPY THE CAMPSITE**
Campsites are first-come, first-serve. Tent, Camper, Vehicle, etc. must be in the site to claim.
- #2 FILL OUT THE GREEN CARD**
Place green card in slot on post.
- #3 PAY THE PARK RANGER**
Park Ranger will collect your payment during your stay.

RULES & REGULATIONS

- Fires allowed in fire pits only.
- No cutting of trees, brush or bark.
- Burning pallets is strictly prohibited.
- Firewood is available for sale from ranger.
- Quiet time hours: 10:00pm - 6:00am.
- Check out time is 2:00pm.

CHENA LAKE RECREATION AREA

GENERAL PARK RULES

1. Chena Lake Recreation Area is open 24 hours/7 days a week. During the summer season, the Lake Park Day Use Area, including the Swim Beach, is closed from 10:00pm to 6:30am.
2. Please swim only in designated swimming areas because of extremely cold water conditions. Rules for swimming beach are posted. Do not swim immediately after meals and do not become over-exerted while swimming. There are no lifeguards. Swimming is AT YOUR OWN RISK.
3. Animals and pets are prohibited in playgrounds and swimming beaches (sand covered areas). Dogs, cats, and other pets must be on a leash under six feet in length. No person shall allow animals to bark or emit other noise which unreasonably disturbs other people.
4. No glass bottles are allowed in the swimming area.
5. The Lake Park Day Use Area (Including the swim beach areas, Pavilion 1 & 2, playground, horseshoe pit, basketball and 3 volleyball courts) is closed to the public at 10:00 p.m.
6. Special permits are coordinated through the Park Manager for special activities, group gatherings, spectator attractions, etc.
7. Visitors must leave the facility clean and orderly.
8. The Lake is closed to all aircraft and motorized boats!!
9. Music can only be played at a volume that does not infringe on other people's enjoyment of the Park.
10. Parking and camping are allowed in designated spots only. Highway vehicles may not leave established driveways and parking areas.
11. No boats are to be within the buoys marking the swimming beach area.
12. Everyone on board a watercraft within the recreation area must wear a personal flotation device at all times. PFD's are available for rent at the boat rental building by the lake boat ramp.
13. No person shall knowingly emit a false drowning alarm.

14. The burning of pallets is prohibited. Fires are to be in designated sites only. Do not leave a fire unattended. Portable barbecue grills are allowed.
15. No fireworks are allowed in the Park.
16. The loading or discharge of firearms, and crossbows, are prohibited for public safety reasons anywhere within the recreation area south of the Chena River and west of the Moose Creek Dike. However, the use and discharge of bow and arrows may be permitted within specifically designated areas and only during ADF&G hunting seasons. An Alaska Sport Fishing License is required to fish in the Park.
17. The setting of a steel trap or snare is prohibited for public safety reasons anywhere within 100 feet of a designated trail or roadway.
18. Do not pick, cut, deface, remove or otherwise damage any flora, fauna, structure, or property in this Park. However, gathering berries or mushrooms for personal consumption, but not for sale or distribution, is allowed. Fines may be issued for property damage. If you find a lost or injured animal of any kind, do not pick it up, but inform a Park employee.
19. Motor-driven scooters and cycles must conform to state licensing laws and their use will be confined to developed roadways. Off Road Vehicle Use is prohibited in the Park from April 1st through October 31st and when their use is deemed detrimental to park grounds.
20. Firewood will be offered for sale by the Park Ranger (907)322-7773. Cutting of timber or brush is prohibited on Park grounds. Chainsaws are not allowed in the Park.
21. All local, state and federal laws apply within the Park.
22. Police emergency services are provided by the Alaska State Troopers. In an emergency, dial "911". For emergencies and/or for general Park information, call (907)488-1655 (Park Office) or (907)322-7773 (Park Ranger).
23. Quiet hours will be observed in the campground from 10:00 p.m. to 6:00 a.m.
